After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. WILDCAT LILY chased the pace three wide, rallied to reach even terms for command at the top of the stretch, gained a slim advantage at the eighth pole, then was fully extended to edge DREAMING OF SUSIE to the wire. The latter, set the pace off the rail, responded when challenged by WILDCAT LILY at the top of the stretch and continued on gamely while being edged to the wire. SPEEDINTHRUTHCITY stalked the leaders off the rail into the stretch but didn't do enough late. BY GOLLY MOLLY unhurried early, swung out for the stretch run and gained some ground without threatening. STREET GIRL reserved in striking position off the pace, lacked the needed response in the drive. TWICE TOLD TALE broke awkwardly, raced three wide around the turn and failed to menace. BAMA ROSE was outrun. GUADALUPE HIGH showed early foot along the inside and faltered.
