After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 122 lbs. Non-winners of \$50,000 twice allowed 3 lbs.; once, 5 lbs.; \$35,000, 7 lbs. A trophy will be presented to the winning Owner. Supplemental nominations of \$2,000 to enter and start. RED ROCKET EXPRESS unhurried early, advanced to reach contention in the stretch but was no match for the winner while up for the place. SR. QUISQUEYANO reserved off the pace, advanced four wide around the turn to reach contention but had no further response and was edged for the place. GOTTA BE FATE failed to menace. R FREE ROLL off slowly, rushed up to vie for the lead outside ROCKYSHOMERUN, dueled with that rival into the stretch and tired. CITY OF WESTON saved ground and faltered. ROCKYSHOMERUN dueled for the lead along the rail into the stretch, then faded.
