LONDON LANE , patiently handled two wide between horses, was put to urging near the three eighths pole, eased out to the five path leaving the final bend, swung to the seven path in upper stretch for racing room outside HYPER, readily responded to a strong drive and closed smartly to get up in the final strides. HYPER , lightly steadied when rated back approaching the first turn, saved ground around the first bend, advanced outside horses on the far turn, was fanned to the six path in upper stretch, closed to bid for the lead outside SWIFT WARRIOR in deep stretch but was out finished by the winner. SWIFT WARRIOR saved ground disputing the pace with TWO NOTCH ROAD, disposed of that one leaving the far turn, opened up in midstretch, held gamely but was passed in the late going. GENERAL LOGAN never far back, was five wide between horses in upper stretch, remained in range of the leader in midstretch but lacked the needed late response. ROADHOG , two wide, chased the pace, was in striking position in upper stretch but weakened the final furlong. AIR SUPPORT , a bit fractious in the starting gate, stalked the pace outside horses, was four deep between horses in upper stretch, but came up empty in the drive. ATIGUN saved ground, steadied behind horses entering the far turn, steadied lacking room near the five sixteenth pole, swung out at the head of the stretch, angled in in upper stretch, steadied when blocked behind ROADHOG in upper stretch, altered course in midstretch and finished with energy. TWO NOTCH ROAD dueled outside SWIFT WARRIOR, turned for home three wide and retreated through the stretch.
