1 1/2 MILES. (1.471) STAKES. Purse \$175,000 *FLEUR DE LIS H. (GRADE II)* FOR FILLIES AND MARES, THREE YEARS OLD AND UPWARD. By subscription of \$175 each, which should accompany the nomination or by Supplementary Nomination of \$5,250 each by 12:00 noon, Friday, June 7. \$875 to pass the entry box; \$875 additional to start, with \$175,000 added. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weights to be announced Saturday, June 8. The maximum number of starters for the Fleur De Lis will be limited to fourteen (14). If more than fourteen (14) entries pass the entry box preference will be given to highweights with consideration to the scale of weights for age. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee and supplementary nomination fee if applicable. Starters to be named through the entry box at the usual time of closing. All supplementary nominations will be required to pay the entry and starting fees if they participate. Trophy to winning owner. Closed Saturday, June 1, 2013 with 15 nominations. (Clear 88)

FUNNY PROPOSITION sprinted clear into the first turn and angled out three wide when clear, set the pace, stayed out in the four path on the second turn, responded willingly in the stretch and drew off late under steady urging. ROYAL DELTA forwardly placed four wide, moved out a path on the second turn, reached closes to the winner after six furlongs, followed that one into the stretch, drifted in to near the rail in midstretch and weakened while holding on for the place. SHE'S ALL IN reserved three wide, made a mild middle move in that path, angled out for the drive but lacked a late bid. ICE CREAM SILENCE within striking distance while in hand and off the rail, stayed on well to the stretch but had nothing left. WINE PRINCESS close up three wide, angled in a bit after six furlongs and tired in the drive.
