After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. BAHAMIAN SQUALL chased the pace three wide, rallied to gain the lead inside the eighth pole, then edged away under pressure. **TRINNIBERG** chased the pace off the rail, made a run to reach even terms for command just inside the eighth pole but couldn't stay with the winner while saving the place. **JACKSON BEND** reserved early, angled out for room in the stretch and closed well to just miss the place. **JUSTIN PHILLIP** stalked the pace three wide into the stretch and finished willingly while being edged for the show. **TRICKMEISTER** stalked the pace along the rail, eased out for the stretch run and didn't do enough late. **CLOSE IT OUT** unhurried after breaking slowly, steadied outside **APRIORITY** on the backstretch, then closed ground late along the inside without threatening. **BLACK DIAMOND CAT** raced four wide and failed to menace. **FORT LOUDON** rated off the pace, raced three wide around the turn and never threatened. **ARTEFACTO** pressed the pace outside **CAJUN BREEZE**, gained a slim lead from that rival nearing the quarter pole, made the pace to past the eighth pole, then tired. **APRIORITY** off slowly, steadied to avoid the broken down horse on the backstretch and was not a factor. **CAJUN BREEZE** set the pace under pressure along the rail to nearing the quarter pole, then faltered. **OFF THE JAK** broke down in the early going and was pulled up.
