AURELIA'S BELLE tucked in and attended the pace in hand, worked her way out from between rivals midway through the second turn, came four wide, engulfed the leader nearing the furlong marker and edged clear. SLOANE SQUARE contested the pace to the outside of STORMY NOVEL through the second turn, shook off that one entering the stretch, was quickly collared again and proved unable to resist the winner. KATIE'S EYES settled in hand, circled five wide to make her bid, churned on diligently to earn the show. LA MEJOR FIESTA bumped at the start and was away slow, advanced between horses through the second turn and continued to improve position in the lane. SUPER SKY settled off of the inside, finished with a mild rally and improved position while failing to threaten. STORMY NOVEL disputed the pace along the inside to the stretch and retreated. ZENSATIONAL BUNNY rushed to contention four wide, was within reach through the second turn and faltered. SHANON NICOLE failed to respond. SWISS LAKE YODELER was allowed to settle five wide and lacked a response when called upon. CHEERFUL CONTENDER was bumped and shuffled back at the start and never recovered. SOMMERVILLE MISS was through early.
