1 1/2 MILES. (1.47) STAKES. Purse \$300,000 *GAZELLE S. (GRADE II)* FOR FILLIES THREE YEARS OLD. No nomination fee. \$1,500 to pass the entry box and an additional \$1,500 to start. A supplemental nomination fee of \$6,000 in addition to the entry and starting fees may be made at any time prior to the closing of entries. The purse to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among the remaining finishers. Certain finishing positions in the Gazelle will earn points to qualify for the 2014 Kentucky Oaks, pursuant to the official rules for the Road to the Kentucky Oaks published by Churchill Downs Incorporated. The winner will earn 100 points, the second place finisher 40 points, the third place finisher 20 points and the fourth place finisher 10 points. 122 lbs. Non-winners of \$60,000 other than restricted stake or \$40,000 twice in 2014 allowed 2 lbs.; \$40,000 at a mile or over in 2014, 4 lbs.; \$40,000 or three races other than maiden or claiming, 6 lbs. A trophy will be presented to the winning owner. Closed Sa turday, March 22, 2014 with 27 Nominations. (Clear 54)

MY MISS SOPHIA away alertly, cut the pace just off the inside in hand, remained patiently handled through moderate fractions until put to encouragement at the head of the stretch, went clear getting shown the stick intermittently while ridden out to the wire. GOT LUCKY brushed the near side stall at the start getting off half a beat slow, settled just off the inside towards the rear, came under prolonged encouragement at the seven-sixteenths, swung four wide for home, offered up a mild kick to procure the place in the last jumps. SWEET REASON broke in at the start and was corrected, tracked the pace inside in aim, got let out angled two to three wide into upper stretch, offered up a mild kick which proved no match for the top one then was caught in the late stages for the place. VERO AMORE chased two to three wide in range of the front, came under urging three furlongs out, continued three wide for home and weakened in the stretch. BIRD MAKER three to four wide in mid pack, came under urging three furlongs out, swung five wide for home, made no impact. WRAITH saved ground towards the rear, grew detached from the main body of the field by midway and trailed.
