Supplementary nominations may be made by the closing time of entries at a fee of \$2,000 which qualifies to start with \$150,000 Guaranteed of which 60% to the Owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to be divided equally between remaining starters. WEIGHTS: 122 lbs. Non-winners of \$50,000 at a mile or over in 2014, allowed 3 lbs.; \$40,000 at a mile or over a ny time, allowed 5 lbs.; \$30,000 at any distance, allowed 7 lbs. (Maiden and Claiming races not considered). In Allowance Stakes starting preference will be given to horses that have accumulated the highest earnings. Starters to be named through the entry box by the usual time of closing. The Owner of the winner to receive a trophy. Certain finishing positions in this race will earn points to qualify for the 2014 Kentucky Oaks, pursuant to the official rules for the Road to the Kentucky Derby published by Churchill Downs Incorporated. Bay Filly, (Jan), by Harlan's Holiday - Three Graces by Doneraia Court. Trainer Asmussen M. Steven. Bred by WinStar Farm, LLC(KY).

SUGAR SHOCK away well, pressured the leader while in hand and well off the rail, collared the leader turning for home, shook clear, lugged out suddenly a furlong out to impede EUPHROSYNE, drifted in under a brisk left handed stick, while clear in front of PLEASE EXPLAIN with a sixteenth remaining, straightened to narrowly cross the wire first. FOLLOWING A CLAIM OF FOUL BY THE RIDER OF EUPHROSYNE AGAINST SUGAR SHOCK FOR INTERFERENCE IN MIDSTRETCH, THE LATTER WAS DISQUALIFIED AND PLACED SECOND. A CLAIM OF FOUL BY THE RIDER OF PLEASE EXPLAIN AGAINST SUGAR SHOCK FOR INTERFERENCE IN DEEP STRETCH WAS NOT ALLOWED. EUPHROSYNE away in good order, stalked the pace off the inside, roused three wide late in the final turn, was closing the gap on the leader when forced to check when SUGAR SHOCK lugged out with a furlong to run, recovered, set down, getting back to that same rival late. PLEASE EXPLAIN devoid of early foot, raced well back for six furlongs, began to move late in the final turn, slight drift, tight quarters mid stretch, wedged between those rivals soon after, slight bother when SUGAR SHOCK came in late, also was going well at the end to be closing the gap in the final strides. KISS MOON settled off the pace and the inside, roused three wide turning for home, brushed with PLEASE EXPLAIN inside the furlong marker, also closed some of the gap late while remaining off the inside. COURAGEOUS JULIE lacked speed, raced off the inside, was six wide turning for home, improved position while well out in the strip. TARIS took control after the start, set a moderate pace just off the inside, weakened in the drive. SPRINGSTEEN ROAD settled off the pace, lacked a response when called on in the drive. IRELAND failed to make an impact from back off the pace, five wide turning for home. DREAM SPINNER in mid pack for a half, began to tire into the far turn. SILK PURSE in the second flight in the two path, steadily faded. MIDNIGHT ECLIPSE fractious in the gate, last away, was never close in showing little.
